## Instructions for Filling Out Quarterly Report

Lines 1, 2 & 3 are self explanatory.

- Line 4** Carry on this line the number shown on the line headed: "Net Membership Good Standing this Report" on your last previous report. If a new Klan, carry the number of charter members on this line.
- Line 5** Carry the number of men naturalized during the quarter. *Do not include ministers or original Klansmen (1870) on this line.* Send in typewritten list of these names, also a form K-115 for each man.
- Line 6** Carry the number of ministers naturalized during the quarter. Send in typewritten list of these names, also a form K-115 for each man. *Ministers pay no Klatskon but do pay Imperial and Realm Taxes.*
- Line 7** Carry the number of men who have been previously suspended, but who have paid all back taxes, including those for the current quarter, and have thus been automatically reinstated during the quarter. Send in typewritten list of these names.
- Line 8** Carry on this line the number of men affiliated with the Klan during the quarter. Send in typewritten list of these names.

"Gross Membership"—On this line show the total of lines 4, 5, 6, 7, & 8.

- Line 9** Itemize the total deductions made during the quarter. *No man should be shown as a deduction unless he is included in the figure shown as "Gross Membership."* Send in an itemized list of these names.

"Total Deductions"—The total of Lines 9a, 9b, 9c, & 9d.

"Net Membership"—"Gross Membership" less "Total Deductions."

- Line 10** The figure shown on this line should be the same as the figure shown on Line 5. If not, account for the discrepancy under "Remarks."
- Line 11a** Imperial Tax for the current quarter is computed on these lines. Imperial Tax is  
**11b** at the rate of .15c per member per month, and begins with the month following the  
**11c** month in which a man is naturalized. For a Klan, it begins with the month following  
**11d** the month in which the charter is delivered.
- A man cannot be transferred unless in good standing, so tax would be computed for the full quarter on men shown on Line 9b. No tax would be computed for men shown on Line 8. *The Klan to which a man is transferred begins paying tax on him with the quarter following the quarter in which he is received.*
- Line 11c** A reinstatement pays back tax for the quarter in which suspended and all intervening quarters until reinstated, and this back tax should be computed on these lines. A minimum of one quarter's back tax is due on all reinstatements.
- Line 12** The same as Line 11, with the exception of the rate.
- Line 13** These are the only lines on the blank where old original Klansmen should be carried.  
**14** If an original Klansman is deducted, give his name and cause of deduction under "Remarks," and deduct him on Line 13. *Do not show the deduction of an old original Klansman on Line 9, as he is not included in "Gross Membership."*
